

Alcohol-related Mortality


Figure 1: Alcohol-related mortality (underlying cause); 2012 to 2016 5-year aggregate, directly standardised rate per 100,000 population




Figure 3: Hospital admissions for alcohol-related conditions by age group, 2014/15 to 2016/17, directly standardised rate per 100,000 population





Figure 4: Hospital admissions for alcohol-related conditions by Intermediate Geography, 2016/17, directly standardised rate per 100,000 population


Figure 5: Hospital admissions for drug-related conditions; 2014/15 to 2016/17 3-yr aggregate, directly standardised rate per 100,000 population


Figure 6: Alcohol Brief Intervention Delivery in Primary Care Priority Settings; 2016/17, crude rate per 1,000 practice population


Figure 7: New clients assessed for specialist drug and alcohol services; 2016/17, crude rate per 1,000 population aged 18 years and over

Figure 8: Off trade premise licenses in force as at October 2017, crude rate per 10,000 population aged 18 years and over


